Directions to APA Recreation Center

From NJ Turnpike

Take the turnpike to last toll (18W) and proceed to route 46 east, go ¼ mile to first exit (Grand Avenue). Make a right on Grand Avenue ¼ mile you will come to a circle. Go around the circle and continue to 85th Street. Make a right on 85th Street. Recreation Center is located at the bottom of the hill on the right side.

From the Lincoln Tunnel

Take exit for 1&9 North and proceed to 85th Street and make a left turn. Recreation Center is located at the bottom of the hill on the right side.

From the George Washington Bridge

Take exit for Route 46 West. Get off at Broad Ave exit. Go left on Broad Ave. until you come to a circle. Go around circle and continue to 85th street and make a right. Recreation Center is located at the bottom of the hill on the right side.
