Rules: The Kata competition will be conducted in accordance with the current procedures of United States Judo, Inc. Entry rules are as follows: Competition will be allowed for the following: Same Gender Male, Same Gender Female, Mixed Gender (One partner male, one partner female) 2. Contestants may select any of the following katas to compete in: Nage-no-kata, Katame-no-kata, Kime-no-kata. 3. A contestant may enter only one kata event once, i.e. cannot enter the same Kata Event with a different partner.

Awards: Awards will be given for first, second, and third-place finishers in each kata. Certificates will be presented as awards.

Early Registrations: Early registrations may be sent in to: Boulder Judo Training Center, Kata Championships, 3070 28th Street, Suite D, Boulder, Co 80301. These must include a separate application packet for each individual (NOT each pair). The application packet sent in must include (1) the completed entry form, (2) the signed waiver/release of liability, (3) a USA Judo membership card (can also be purchased at event if stated as such), and (4) the entry fee.

WARNING, WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE:

In consideration of being permitted to participate in any way, including travel to and from, the Boulder Judo Training Center Kata Championships, and related events and activities of United States Judo, Inc. (dba USA Judo), I hereby:

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.
2. Agree that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, and severe social and economic losses due to not only my own actions, inactions, or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability, or death.
5. Release, waive, discharge and covenant not to sue the United States Judo, Inc. (dba USA Judo), the United States Olympic Committee, Colorado Judo League, the Boulder Judo Training Center, the Olympic affiliates, the City of Boulder, and the State of Colorado together with their affiliated clubs, their respective administrators, directors, agents, coaches and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, guardians, supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees of premises used to conduct the event, all of whom are hereinafter referred to as "releasee", from any and all claims, demands, losses, actions, causes of actions or damages on account of injury, including permanent disability and death and damage to property (Collectively, "Liabilities"), caused or alleged to be caused in whole or in part by the acts or omissions of the releasee, even if arising from their negligence, OR OTHERWISE to the fullest extent permitted by law.

I HAVE READ THE ABOVE WARNING, WAIVER AND RELEASE, UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND KNOWING THIS, SIGN IT VOLUNTARILY. I AGREE TO PARTICIPATE KNOWING THE RISK AND CONDITIONS INVOLVED AND DO SO ENTIRELY OF MY OWN FREE WILL.
